# A Letter to OAFA Members ...

#### Dear Art Educators,

As a member of our Arts organization, National Art Education Association/Oklahoma Art Education Association, and a passionate educator in the state of Oklahoma for more than forty years, I felt compelled to write this letter/article in hopes of starting a dialogue and posing a few questions/thoughts for each of us to consider and reflect upon as we go forward in our careers as visual arts teachers. The concerns I have are heavy on my heart. My inquiry is an outreach to all art educators, K-12 to consider our teaching methodologies and to take a deeper look at some of the terms associated with plagiarism, copyright infringement, fair trade and more, when we are in our classrooms teaching our students about art making.

My concerns were brought to surface during the 2015-16 school year viewing art that was accepted into most all of our state competitions, however, they go far beyond this and right into the hearts of our classrooms. This is not a new topic of concern. I have personally fallen victim to students violating copyright laws and even plagiarizing art work! When I first started teaching in OKC public schools, I had a student that was behind in his 3-D work. He came to me one morning and showed me a beautiful balsa wood oil well. It was wonderful! I asked him all the right questions: Did you cut each piece of wood yourself? You glued everything together and designed the entire piece yourself? And so on, each time his reply was an emphatic, yes! I decided to enter his additive sculpture work in our OAEA Young Talent in Oklahoma juried show. It did not get in, thank goodness. I am sure you know where this is going...and you guessed it! A month or so later I was on my way to Tulsa and went into a gas station and low and behold, inside I faced a huge table with packaged kits of the exact same oil well. I was heartbroken! My student had been dishonest with me! Fast forward to 2015. Same story, only this time it was a student in my AP Drawing class. The work had been entered as part of her Scholastic Arts Portfolio. She brought it to class one day and I loved it, carrying on about how expressive and inventive it was. When it came time to enter her portfolio, this piece was not included?! Following our discussion, she said she would "put it in", which she did. After the jurying process, and the Silver Portfolio Award she was awarded, I received an envelope from our Regional sponsor. In the envelope were pages of the same image that had been retrieved from the internet in multiple places!

I was stunned. I was in shock!! As all this unfolded, my student happened to be standing at my desk. We carried on detailed and intense talks. My final conclusion is that she did not know how to tell me it wasn't her work (especially since I thought so much of it) due to the fact that I teach often about plagiarism, copyright infringement, etc. My students know that I do not accept art work that falls into these categories! So, I write this letter having experienced these issues myself! Here is a note about the position of NAEA:

It is the position of the NAEA that students should act ethically when using existing imagery to research and/or create original art. Students should see, know, and experience art and art history through original source material and/or quality reproductions in order to examine, understand, and create original research or artwork. Students should appropriately credit original sources in their written work. When developing art, even when using a variety of sources, students and teachers should understand the appropriate use of copyrighted and public domain imagery. Students should be encouraged to go beyond published art to develop concepts and ideas from direct observation, experiences, and imagination. Please note, the word "original" was used four times in this statement!

In addition to the obvious negatives, it is very disheartening and breaks trust, as illustrated above, when this occurs. We are the leaders, teachers and advocates of art education. Our ethical obligation, moral commitment and passion to teach studentsto think creatively (while they develop and use higher level thinking skills) during an act of **authentic** (*original*) art makingmust be at the core of our instruction. I find it troublesome that works are being completed in classrooms that allow for students to copy the work of other artists. Whether it be completing a drawing from a published photograph (someone else's artwork), recreating a clay tea pot that another artist has modeled or painting another artist's painting, do we want to consider that these acts are true, authentic and *original* art making experiences? How can we accept this in our teaching? It is simple- we cannot and we must not!

Scholastic Art and Writing Awards helps define all terms related to copyright infringement and plagiarism. There is a wealth of information on their site. I share this article with my students each school year and include it in my Advanced Placement Summer Institute teaching materials as well. I highly recommend that you visit the link below, learn the language and then allow this information to guide your teaching. This will create an atmosphere of understanding as students approach their own art making. By the time my students reach AP Classes, they knowthe implications- both ethically and legally. This article Copyright & Plagiarism: A Guide for Students & Educators-http://www.artandwriting.org/the-awards/copyright-and-plagiarism/, clearly distinguishes Plagiarism from Copyright Violation. Public Domain is defined as is Fair Use terms. It is an outstanding teaching tool!

In the curriculum of the College Board AP Studio Art courses it is written- "If you submit work that makes use of photographs, published images, and/or other artists' works, you must show development beyond duplication. This may be demonstrated through

manipulation of formal qualities, design, and/or concept of the original work. It is unethical, constitutes plagiarism, and often violates copyright law to simply copy an image (even in another medium) that was made by someone else."

In our world of technology, the access is wider, the temptation greater and the acts of plagiarism and copyright violations are more complex and commonplace today, more than ever. Is it acceptable for students to create work that ignores these laws which represent high ethical standards? Do we knowingly allow this in our classrooms? It is time for us to take a stand against violations of these laws both in our classrooms and our state competitions! It is our place to teach these values/standards to our students. I know and hope you agree. Defining plagiarism and copyright infringement laws is as important as teaching them technique and skill, compositional arrangement and color theory, etc. Actually, it is more important in this age of the internet, social media and technology.

The question may come up- how do we, as art teachers, know if they are borrowing ideas and imagery from another artist? The answer is - we don't always know! As always, relationship plays an important role and I believe one option is to witness their processes as much as possible. Often, borrowed ideas and /or artwork is obvious, but sometimes we do find out the hard way...what a lesson to be learned, both for the teacher and the student! However, all this being said, if you teach students the terms and they clearly understand your position, then when and if it does occur, you know you have done everything in your power to prevent it. And, you do not have to accept the artwork! It is truly about educating ourselves and in turn our students.

As an AP Consultant and Reader, I have the opportunity to discuss and share much of the information concerning plagiarism and copyright laws with teachers in states in our southwest region and beyond. This is a problem that exists everywhere! Taking into account a comparison of the AP rubrics whether it be 2D design, 3D Design or the Drawing Portfolios, the benefits of students creating original art work is obvious. Here is a comparison of the Excellent (6H) and the Poor (1H) rubrics concerning these issues in the Quality section of the Drawing Portfolio:

Excellent Score capability - Quality - 6.H - Any apparent appropriation of published or photographic sources of the work of other artists clearly provides a visual reference that is transformed in the service of a larger, personal vision.

<u>Poor Score capability - Quality - 1.H</u>-The works are obviously direct copies of published or photographic sources or the work of other artists and are poorly rendered; there is no discernible student vision or individual transformation.

Visiting the AP Studio Art Rubrics (<a href="http://studioartportfolios.collegeboard.org/wp-content/uploads/2015/09/2015-AP-Studioing-Guidelines.pdf">http://studioartportfolios.collegeboard.org/wp-content/uploads/2015/09/2015-AP-Studioing-Guidelines.pdf</a>) one can read the full range of scores to include the rubrics of 5H Strong,

4H –Good, 3H Moderate, and 2H – Weak.I encourage you to take a look and share them with your students!



# Member Professional Development

#### The Oklahoma Art Education Association offers hands-on art workshops for Oklahoma K-12 Art Teachers

A workshop was held with Department Chair and Artist-in-Resident **Mike Wimmer** of the **Oklahoma City University Art Department on Saturday, April 16<sup>h</sup>, 2016, 9:00 am to 5:00 pm.** The workshop covered safe and efficient ways to work in oil paint, mixing color, preparing surfaces, and procedural rules. Additional technical skills were covered in how to creatively illuminate the subject, capturing a likeness through proper comparative measurements, how to create illusion of form through use of values and projecting realistic skin tones with limited color. Participants enjoyed the workshop and look forward to other opportunities like this one.





## June Collage Workshop Scheduled at ECU

The next workshop, with **Art Department Chair and Artist Brad Jessop of East Central University, is Saturday, June 25<sup>th</sup>, 2016, 9:00 am to 5:00 pm.** The workshop will focus on 4 major methods artists typically use to create collages: 1.) Image Harvesting and Juxtaposition: in which complete images are tightly cut and juxtaposed to related images fostering new meaning; 2.) Form Harvesting: in which sections of images are used to re-invent images, similar to cubism, often embracing fragmented space and time; 3.) Color Harvesting: where small chips of chromatic printed material are reassembled to create new abstract or realsitc images; 4.) Combines: that can incorporate the previous methods and/or additional media and processes. Basic materials will be provided with a supplemental supply list sent to workshop participants. The workshop is open to 25 participants and the **deadline for registration is 5pm, Monday, June 6th, 2016.** After this date if there are over 25 registrants a lottery system will be used to identify the final participants. Five spaces will be issued to new OAEA members with the remaining seats filled from the pool of applicants. Notification of <u>final workshop participants and a supply list will be emailed on Tuesday, June 7<sup>th</sup>. The cost to workshop participants is \$ 20 for members and \$25 for non-members, payment required in advance.</u>




