This should include superior programs of sequential, curriculum-based arts education.

In addition, the selection committee will look for strategies used by administrators, school boards, and arts educators that encourage partnerships between school arts programs and cultural resources in the community.

Award recipients will be recognized at the State Superintendent Awards for Arts Excellence ceremony on **Tuesday, April 25, 2017**, at the Scottish Rite Temple in Guthrie, Oklahoma.
