Celebrate your student artwork at the OAEA Youth Art Gallery at Will Rogers Airport in OKC! You are invited to submit <u>PHOTOS</u> of student artwork for the Will Rogers World Airport Youth Art Gallery Program, a partnership between the Airport and OAEA. The Gallery is located on Level 2 in the West Meet and Greet Lobby.

Artwork is displayed in **fifteen 18 by 24 frames.** Our first exhibit was installed in September 2019 (with all original artwork.) Now we use digital images from teachers with **high resolution color copies.**Important: Please <u>email photos</u> in jpg format of artwork by Monday <u>APRIL 1, 2024</u> for display from mid <u>APRIL 2024</u> to mid <u>OCTOBER 2024</u>. Artwork from Kindergarten to 12th Grade is needed. Choose student artwork for <u>one 18 by 24 inch frame</u>. We can get prints sized up to 12" by 18" for a single art piece, and either 8.5 by 11" or 9 by 12" for two smaller pieces. See sample photos.

Please use **your best judgment** when choosing artwork appropriate for public viewing, and avoid artwork that may infringe on copyright. You can also send a photo of **3-D work like ceramics or sculpture**. **Look for strong contrast, good use of color, line, value, texture, etc.** No group projects.

We must adhere to the required guidelines currently in place at this public location: "Works shall not contain obscene, pornographic or violent material; market tobacco products, hard liquors, or illegal/prohibited substances; contain commentary, advocacy, or promotion of or on social, political, religious, or rhetorical issues; advocate for or against political candidates, political campaigns, ballot measures, or political parties or organizations; or advocate a position (directly or indirectly) on any public policy or social issue." (From Airport Commission)

We must have signed forms to display artwork. A parent letter is available for optional use. Photos of the gallery are on the OAEA website (under Events tab) and Facebook page. PDF permission forms may be scanned and emailed, or a photo of the form can be emailed or texted.

DEADLINE: Monday April 1, 2024. (email forms and art photos sooner if possible)
